LEWISBERRY BOROUGH COUNCIL MEETING

TUESDAY, SEPTEMBER 4, 2012

The meeting was called to order by Robert Griffith, President leading in the Pledge of Allegiance to the Flag.

RECOGNITION OF PUBLIC

- Sargent J. Smith of the Newberry Police Department reported the following:
- o There were twenty-two (22) calls in the Borough for the month of August 2012.
- Officer Myers has been receiving off duty complaints from borough residents and asks that residents file an official complaint with the department.
- o Manager Greene stated information had been requested from Officer Tyson regarding an abandoned vehicle on West Front Street and as of yet has had no response. Sargent Smith will look into this.
- Byron Trout of Gordon Brown & Associates stated he has the application for the MS4 Stormwater Waiver completed. He asks council to approve the application for signature and submission.
- Resident Brooke Miller of 104 W. Front Street, submitted a petition in show of support for the keeping of chickens in the Borough. She is asking council to reconsider passing proposed Ordinance 2012-01 amending Ordinance §2-101 and banning residents from housing chickens within the Borough.
- Resident Scott Six of 208 West Front Street stated he as well spoke with residents of Lewisberry and found the majority of the Borough is in support of the Miller's request. Discussion ensued. Mark <u>KEENER</u> made a motion which was seconded by Daniel <u>SOLTIS</u> to pass Ordinance 2012-01 with the exception that council grandfathers three (3) of the Millers chickens. Motion denied, 3-4, with Robert Smith, Robert Griffith, Nora Sowers and Mary Pelton voting no. Further discussion ensued. Mary <u>PELTON</u> made a motion which was seconded by Robert <u>SMITH</u> to approve Ordinance 2012-01 banning chickens in the Borough. Motion carried, 4-3, with Mark Keener, Daniel Soltis and William Thompson voting no. Ordinance 2012-01 shall become effective September 28, 2012.
- Robert Timko, President of the Fairview Township Fire Department reported the following:
 - o There was no (0) calls in the month of August 2012 for the Borough.
 - o Officer Myers stated Newberry officers have been receiving reports while off duty.

SOLICITOR'S REPORT

- Solicitor Altland stated the following:

Mayor's Report:

- An Ordinance violation letter has been sent to 210 Market Street for the lack of upkeep with the grass and weeds.
- The registration of the Chevy Trailblazer parked on W. Front Street has expired which makes it legally acceptable for the Borough to ask for it to be removed. The Newberry Police have been asked to identify the owner of the vehicle so that an ordinance violation letter can be sent. Manager Greene will follow up with this.

Road Commission:

Robert Smith stated the following:

• Terence Yinger and himself have cut and cleared more brush and raked leaves. Also, a report was received for a low wire at 3rd and Lewis Streets. Robert Smith will look into this.

Electric Commission:

William Thompson stated the following:

- He attended the PMEA conference.
- The Cumberland County Tax Commission (CCTC) has moved their location to 21 Waterford Drive, Mechanicsburg.
- West Shore School District has withdrawn their support of the West Shore Recreation Commission as well as Newberry Township.

Building and Grounds Commission:

- Robert Smith presents a sign-up sheet and asks for volunteers to paint the Borough Park Building.
- Mary Pelton states the library has their annual chili cook-off coming up on October the 22nd.

Fire Protection Commission:

- Fairview Township hosted a movie night at the Fire Station and had a nice turnout.
- A side-by-side refrigerator was donated to the Fire Station.

The cost to make the necessary repairs is estimated to be \$500.00. Discussion ensued. Robert **SMITH** made a motion which was seconded by Mark **KEENER** approve the cost of the necessary repairs. Motion carried, 7-0.
