Road Committee:

- Councilman Scott Six states the following:
 - O Presents quotes from J.R.'s Driveway Repair and Willie's Paving Inc. for work to be done on 5th Street, Walnut Lane and Front Street. Discussion ensued. William <u>THOMPSON</u> made a motion which was seconded by Mary <u>PELTON</u> to approve the quote submitted by Willie's Paving Inc. for the repairs of a small portion of Front Street, Fifth Street and Walnut Street. Motion carried, 5-0.

- Solicitor Altland reviews the Bid Specifications submitted by Byron Trout of Gordon L. Brown & Associates. States the bid should not go out as written. Discussion ensued. Solicitor Altland will speak with Byron Trout.

Electric Committee:

Insurance Committee:
