• Council President Mark Keener states correspondence from the York County Planning Commission seeks to update a map outlining the Borough's public/private roads. Discussion ensued. Manager Greene will contact the Commission to verify what it is that they are asking for.

Electric Committee:

- William Thompson stated the following:
 - Reviews two proposals submitted for a contract extension with NextEra for the 2018-2022 Non-Pool Power Contract. The recommendation is for council approve Proposal #1, with a blended price of \$64.63 per Mwh for the period of 9/1/2017 thru 12/31/2027. Discussion ensued. William THOMPSON made a motion which was seconded by Maureen BEREZNAK to approve Resolution 2017-04 putting AMP Contract No. 20023-0042121-AMD into effect. Motion carried, 5-0.
 - Distributed the PMEA Electric Rate Comparison Table and a Comparison Table of how House Bill 1405, if it were to be passed, would affect the Borough's Real Estate taxes. Discussion ensued.
 - Spoke with Mike Simpson from Henkel's & McCoy, Inc., his crew is currently busy with Hurricane Crews but will get the electric pole replaced within the next couple of weeks.
 - Spoke with Mike Dubbs, asked him to remove the street light test meter and address a problem at 204 Market Street. There is 200 Amp service going into that property and the wires cannot take the load, he would like to purchase 1Ø electrical wire from Graybar. Discussion ensued. Manager Greene will look into setting up an account.
- Mark Keener stated the following:
 - o While Mike Dubbs is in the area the light at the Fire House is on continuously.
 - Electric Biller Stacie Chornak met with Jeff Schmidt of Elk Systems, Inc. He feels that he can effectively maintain the Borough's electric billing software, however he requested access to the program to more closely review it. His fee for any services rendered is \$125 per hour, however he is willing to invoice the Borough in ¼ hours. Discussion ensued. Council is ok with the fee schedule.
