# LEWISBERRY BOROUGH COUNCIL MEETING

# MONDAY, MARCH 5, 2018

- Solicitor Altland states Council Members should have a copy of the 2017 Profit/Loss Operating Costs for the Community Building prepared by Borough Manager Mackensie Greene as stipulated by the Lease Agreement between Redland Community Action Program (herein after referred to as "REDCAP"), the Borough of Lewisberry and the Annie E. Sterline Library. The total rental income for 2017 was \$16,949.00 and the expenses were \$33,203.60, leaving a deficit of -\$16,254.60. The proposed annual rental increases are as follows: Lewisberry Borough, from \$852.00 to \$1,160.18, REDCAP, from \$11,856.00 to \$23,242.52, and Annie E. Sterline (currently paid by Lewisberry Borough) from \$4,241.00 to \$8,300.90. Discussion ensued. Decision Tabled.
- President Keener brought forth a quote submitted by David Forgas of Forgas Landscaping for the cleanup of the Borough Park and 5<sup>th</sup> Street Extension in the amount of \$175.00. Discussion ensued. Daniel <u>SOLTIS</u> made a motion which was seconded by Patrick <u>GROFT</u> to accept the quote as written. Motion carried, 5-0.
- Councilman Patrick Groft stated he will be opening the Park Building the following week and will be meeting with Joey Thomas to get an estimate to replace some of the plumbing with pex.
- The lights out front of the Community Building are still not working. Discussion ensued. Mike Dubbs will be called to look at the issue.

# Library Report:

- Sandra Fogle stated the following:
  - o March 17<sup>th</sup> they will be holding a Book, Soup & Bake sale at the Park Building from 8-2.
